



NEBRASKA STATE CHAPTER ACHIEVEMENT AWARD

The purpose of the Nebraska State Chapter Achievement Award is to honor chapters in recognition of outstanding leadership, contributions, and services rendered in promoting the purposes of The Delta Kappa Gamma Society International. The Leadership Development Committee shall determine which chapter meets the highest criteria. Any member or chapter may submit nominations for the award by February 15 of any given year.

The award, which will be presented at state convention, shall include a certificate, the chapter's name added to a traveling plaque, and \$100 to be used for the chapter's scholarship fund, grant-in-aid fund, or president's expenses at international convention.

GUIDELINES FOR THE CHAPTER

1. The chapter president, or designee, shall attend the Nebraska State Convention, Chapter president training at Nebraska State Convention, and International Conference (odd year) or International Convention (even year). **10 points each**
2. Ten percent (10%) of the officers and committee chairmen shall attend the Nebraska State Convention and the Nebraska State Leadership Workshop. **10 points each**
3. Ten percent (10%) of the total active chapter membership shall attend the Nebraska State Convention. (The officers and committee chairmen would be counted as part of the ten percent.) **10 points**
4. Five percent (5%) of the total active chapter membership shall attend the Regional Conference or International Convention. (The officers and committee chairmen would be counted as part of the five percent. Active membership includes all the members except reserve members). **10 points**
5. Chapter attendance at regularly scheduled chapter meetings shall be 50 percent of the active membership. **20 points**
6. The chapter shall initiate, reinstate, or receive by transfer new members between March 1 and March 1. **2 points per new member**
7. Excellence in Education/Program of Work: Describe three (3) outstanding programs presented at chapter meetings during the year. Explain how they address the purposes/goals of Delta Kappa Gamma. **0 to 10 points each, up to 30 total points**
8. Service Project: Describe your chapter service project. Explain how it addresses the purposes/goals of Delta Kappa Gamma. **0-10 points**
9. The chapter shall participate in the Nebraska State service project. **5 points**
10. Tie breaker: Number of chapter members currently serving as state officers or state committee chairs. **1 point each**
